**RESOLUTION NO. 386, S-2021**

**AUTHORIZING MUNICIPAL MAYOR LEOPOLDO N. BATAOIL AND MUNICIPAL TREASURER LILIBETH A. MANAOAT TO ENROLL THE MUNICIPALITY OF LINGAYEN IN THE ELECTRONIC PAYMENT SYSTEM (EPS) OF THE LAND BANK OF THE PHILIPPINES IN PURSUANT TO PHILHEALTH CIRCULAR NO. 2020-008; AND FURTHER AUTHORIZING NELSON S. GUMAPOS, MUNICIPAL ACCOUNTANT AND AGNES R. FERNANDEZ, ACCOUNTANT III, AS MAKER; AND LILIBETH A. MANAOAT, MUNICIPAL TREASURER AND HARRIS CRUZADA, LOCAL REVENUE COLLECTION OFFICER II, AS AUTHORIZERS OF THE SYSTEM.**

WHEREAS, pursuant to PhilHealth Circular No. 2020-008, employers are required to enroll their Electronic Premium Remittance System (EPRS) account at any Accredited Collecting Agent (Land Bank of the Philippines) with payment gateway/facility interlinked with EPRS to be able to remit premium online;

WHEREAS, the Local Government Unit of Lingayen, Pangasinan recognizes the necessity of enrolling the Municipal Current Account No. 2422-1033-95 with the online payment facility of the EPRS introduced by PhilHealth as it provides faster acknowledgement of premium payments thereby providing ease, convenience and security to employers;

WHEREAS, to avail of the facility and system, there is a need for the passage of a resolution to expedite the processing of appropriate electronic transmission/s and to easily track down the history of payment;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBMs Mac Dexter G. Malicdem and Jasper S. Pasion, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Municipal Mayor Leopoldo N. Bataoil and Municipal Treasurer Lilibeth A. Manaoat to enroll the Municipality of Lingayen in the Electronic Payment System (EPS) of the Landbank of the Philippines in pursuant to PhilHealth Circular No. 2020-0008; and further authorizing Nelson S. Gumapos, Municipal Accountant and Agnes R. Fernandez, Accountant III, as maker; and Lilibeth A. Manaoat, Municipal Treasurer and Harris Cruzada, Local Revenue Collection Officer II, as authorizers of the system.

RESOLVED FURTHER, to authorize the Land Bank of the Philippines to debit above-mentioned account upon the instruction of the Local Government of Lingayen.

RESOLVED FURTHERMORE, that this resolution shall be deemed valid and effective unless written notice of its revocation or amendment is delivered to the Land Bank of the Philippines.

RESOLVED FINALLY, that copies of this resolution be furnished to Land Bank Lingayen Branch, Office of the Mayor, Office of the Municipal Accountant, Office of the Municipal Treasurer and other concerned offices for their information and guidance.
