**RESOLUTION NO. 387, S-2021**

**REQUESTING HONORABLE GOVERNOR AMADO I. ESPINO III TO ENTER INTO A DEED OF USUFRUCT OR DONATION WITH THE PHILIPPINE NATIONAL POLICE FOR THE USE OF A PROVINCIAL GOVERNMENT LOT SITUATED AT BARANGAY POBLACION, LINGAYEN, PANGASINAN AS PROPOSED SITE FOR THE PNP POLICE COMMUNITY PRECINCT, THIS MUNICIPALITY.**

WHEREAS, the Philippine National Police is the primary enforcement agency entrusted to promote and maintain peace and order, and ensure public safety and security in the country;

WHEREAS, Municipal Mayor Leopoldo N. Bataoil has requested the Philippine National Police for the funding of three (3) Police Community Precincts (PCPs) of the Lingayen Police Station in line with the PNP's modernization program;

WHEREAS, as proposed by the Local Chief Executive, the three (3) Police Community Precincts (PCPs) shall be strategically located in the central, western and southern parts of Lingayen to provide better police visibility capability, and to quickly and efficiently respond to call for assistance by the people of the community;

WHEREAS, as a mandatory requirement, the Philippine National Police is asking for the possible donation of lot with a minimum lot area of 150 square meters for the PCP Building in favor of the agency;

WHEREAS, the Municipal Government exerted its best efforts to locate a suitable municipal lot as venue for the edifice but failed; it however found an ideal spot for the building, albeit, belonging to the Provincial Government;

WHEREAS, insomuch as the provincial seat of government is situated in this capital town, and shall likewise benefit from the gains of this undertaking, the municipality is emboldened to request the Provincial Government for the utilization of a parcel of lot located along Alvear Street, this municipality as venue for one of the PCPs;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBMs Mac Dexter G. Malicdem and Jasper S. Pasion, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Honorable Governor Amado I. Espino III to enter into a Deed of Usufruct or Donation to the Philippine National Police for the use of a Provincial Government Lot situated at Barangay Poblacion, Lingayen, Pangasinan as proposed site for the PNP Police Community Precinct, this municipality.

RESOLVED FURTHER, that a copy of this resolution be furnished to the Office of Governor Amado I. Espino III for his information and appropriate action.


