RESOLUTION NO. 391, S-2021

REQUESTING HON. WENDEL E. AVISADO, SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE TEN MILLION PESOS (₱10,000,000.00) FOR THE INSTALLATION OF SOLAR STREETLIGHTS ALONG SITIO BAYBAY AND SITIO BUKIG IN BARANGAY SABANGAN, THIS MUNICIPALITY.

WHEREAS, solar street lights are light devices that are activated through the photovoltaic or PV panels and are equipped with a rechargeable battery that can be loaded with electrical power when detecting light from a source such as the Sun;

WHEREAS, solar-powered streetlights play a crucial role in building sustainable communities;

WHEREAS, with the high cost of electricity, communities and municipalities are finding innovative ways to keep the cost of electricity low, and one good solution is the use of solar-powered street lights which removes the electricity burden on the members of the community and the barangay or municipal coffer;

WHEREAS, the installation of solar street lights will help flourish the community by making the place more accessible and welcoming and will help create a safer environment for its dwellers and visitors;

WHEREAS, the presence of solar street lights can help prevent commission of crimes and reduce the number of accidents, thereby promoting better traffic flow while maintaining the safety of everyone in the community;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Hon. Wendell E. Avisado, Secretary of the Department of Budget and Management (DBM) to allocate Ten Million Pesos (₱10,000,000.00) for the installation of solar streetlights along Sitio Baybay and Sitio Bukig in Barangay Sabangan, this municipality.
