**RESOLUTION NO. 392, S-2021**

**REQUESTING HON. CONGRESSMAN MICHAEL EDGAR Y. AGLIPAY, ASSISTANT MAJORITY LEADER, DIWA PARTY LIST, TO ALLOCATE FUNDS AMOUNTING TO TEN MILLION PESOS (P10,000,000.00) FOR THE CONSTRUCTION OF A MULTI-PURPOSE BUILDING IN BARANGAY POBLACION, LINGAYEN, PANGASINAN.**

WHEREAS, DIWA Party List is an organization which protects workers' rights and promote workers' welfare for a just and humane society;

WHEREAS, Barangay Poblacion of the Municipality of Lingayen has a population of 12,238 people based on the 2015 census; and being at the heart of the municipality and province, it is home to government offices, school institutions, business establishments and recreational and tourism sites;

WHEREAS, despite its many inhabitants, the barangay has only one 3-storey edifice which functions as Barangay Hall and Multi-Purpose Building which is not spacious enough to accommodate a large number of people;

WHEREAS, there is a need to construct a bigger and wider Multi-Purpose Building in Barangay Poblacion to serve as venue for numerous barangay activities, trainings, and seminars on varied topics particularly livelihood and income generating projects, and to function also as an evacuation center for people to go to in times of calamities and disasters;

WHEREAS, as a coastal barangay, many residents of Poblacion live near the shoreline making them prone to storm surges and high tides which tend to engulf their residences, prompting them to flee their abodes and seek refuge in government designated evacuation centers;

WHEREAS, a large number of these Poblacion residents are daily wage workers who could hardly make both ends meet, more so, in this prevailing global pandemic which has affected their income and job security, putting them on the verge of poverty;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Hon. Congressman Michael Edgar Y. Aglipay, Assistant Majority Leader, DIWA Party List, to allocate funds amounting to Ten Million Pesos (P10,000,000.00) for the construction of a Multi-Purpose Building in Barangay Poblacion, Lingayen, Pangasinan.

RESOLVED FURTHER, that a copy of this resolution be furnished to Hon. Congressman Michael Edgar Y. Aglipay, House of Representatives, Quezon City, for his information an appropriate action.
