RESOLUTION NO. 393, S-2021

CONFIRMING THE APPOINTMENT OF ARCH. NELCO PAUL P. COQUIA AS MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC) OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, the appointment of Arch. Nelco Paul P. Coquia as Municipal Planning and Development Coordinator (MPDC) with Salary Grade 24, has been referred to the Sangguniang Bayan for confirmation;

WHEREAS, Arch. Nelco Paul P. Coquia has been screened and found qualified by the majority of the Human Resource Merit Promotion and Selection Board (HRMPSB) during a deliberation held on February 24, 2021;

WHEREAS, the vacant position of Municipal Planning and Development Coordinator (MPDC) is a mandatory position prescribed under Article VI, Section 476 of Republic Act 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Section 443 (d) of the same Code provides that unless otherwise provided, heads of departments and offices shall be appointed by the *Municipal Mayor with the concurrence of the majority of all the Sangguniang Bayan Members*, subject to Civil Service law, rules, and regulations;

WHEREAS, due to the exigency of service, the Sangguniang Bayan promptly deliberated on said appointment and after careful consideration and scrutiny of his credentials and experience, it was ascertained by the Body that he is highly qualified for the position and could be a valuable asset to the local government of Lingayen;

WHEREAS, the Municipal Planning and Development Coordinator (MPDC) shall initiate the formulation of plans and oversee the implementation and comprehensive development planning in Lingayen to support the initiatives of the municipal leadership to achieve an improved quality of life for its people;
