RESOLUTION NO. 403, S-2021

ADOPTING AND APPROVING THE LOCAL YOUTH DEVELOPMENT PLAN (LYDP) FOR 2021-2023 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, the State recognizes the vital role of the youth in nation-building and thus, promotes and protects their physical, moral, spiritual, intellectual and social well-being, inculcates in them patriotism, nationalism, and other desirable values, and encourages their involvement in public and civic affairs;

WHEREAS, towards this end, the State shall establish adequate, effective, responsive and enabling mechanisms and support systems that will ensure the meaningful participation of the youth in local governance and nation building;

WHEREAS, Republic Act No. 10742 otherwise known as the SK Reform Act of 2015, ensures wide and sectoral youth participation in governance. It institutionalizes the creation of a Local Youth Development Council (LYDC) to assist the planning and execution of projects and programs of the Sangguniang Kabataan (SK) and the Pederasyons in all levels;

WHEREAS, the SK Reform Act of 2015 requires the formulation of a 3-year Local Youth Development Plan (LYDP) which embodies development programs, projects and activities for the benefit of the youth organizations and youth serving organizations embodied under the Sangguniang Kabataan;

WHEREAS, the Local Youth Development Plan (LYDP) shall serve as the basis for preparation of the Sangguniang Kabataan for the Comprehensive Barangay Youth Development Plan (CBYDP) and other local youth development plans in their respective barangays;

WHEREAS, after careful study of the submitted Plan, it was found out to be in order by the Sangguniang Bayan;

WHEREFORE, on motion of SK Federation President, Gabriel Ivan C. Tuazon, duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to adopt and approve the Local Youth Development Plan (LYDP) for 2021-2023 of the Municipality of Lingayen, Pangasinan.
