RESOLUTION NO. 405, S-2021

INDORSING THE PROPOSED INSTALLATION OF SOLAR LED STREETLIGHTS WITHIN THE MUNICIPALITY OF LINGAYEN, TO HON. WENDEL E. AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND-FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FALGU) IN THE FY 2021 GENERAL APPROPRIATIONS ACT (REPUBLIC ACT NO. 11518) AMOUNTING TO TWENTY MILLION PESOS (P20,000,000.00).

WHEREAS, one of the topmost priorities of the local government is to achieve a peaceful and serene community for the people; germane to this goal is the installation of Solar Led Streetlights which will illuminate the municipality at night time making it more appealing to visitors, passersby and residents alike;

WHEREAS, many parts of Lingayen are not yet adequately lighted, thereby posing constant threat to the safety and security of the constituents and commuters who regularly traverse its roads/streets at night;

WHEREAS, the provision of adequate lighting within the jurisdiction of the municipality will greatly contribute to the promotion of peace and order in the community, deterrence of crimes, burglary, and accidents and the enhancement of the well-being and general welfare of the people of the community;

WHEREFORE, on motion of SBM Jasper S. Pasion, duly seconded by SBM Ricardo R. Ferrer, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to indorse the proposed installation of solar led streetlights within the Municipality of Lingayen, to Hon. Wendel E. Avisado, Secretary, Department of Budget and Management (DBM), to be funded under the Local Government Support Fund-Financial Assistance to Local Government Units (LGSF-FALGU) in the FY 2021 General Appropriations Act (Republic Act No. 11518) amounting to Twenty Million Pesos (P20,000,000.00).
