**COMMENDING THE PHILIPPINE NATIONAL POLICE TEAM OF LINGAYEN UNDER THE LEADERSHIP OF POLICE LIEUTENANT COLONEL JOSE L ABAYA II, ACTING CHIEF OF POLICE, FOR LEADING THE SUCCESSFUL CONDUCT OF ANTI-ILLEGAL DRUGS OPERATION (BUY-BUST OPERATION) IN BARANGAY POBLACION, LINGAYEN, PANGASINAN ON APRIL 19, 2021.**
