ADOPTING THE GUIDELINES FOR THE IMPLEMENTATION OF THE FINANCIAL ASSISTANCE PROGRAM FOR INDIVIDUALS IN CRISIS SITUATIONS IN THE LOCAL GOVERNMENT UNIT OF LINGAYEN.

WHEREAS, the Department of Social Welfare and Development (DSWD), as a leader in social protection, is mandated to work towards the achievement of the improved capacities and opportunities of the poor, vulnerable and disadvantaged individuals and families and communities, to enable them to improve their quality of life;

WHEREAS, to pursue this quest, the DSWD continuously implements social welfare and development, social protection, and anti-poverty programs and projects in partnership with various intermediaries;

WHEREAS, the Assistance to Individuals in Crisis Situations (AICS) is part of DSWD's protective services for the poor, marginalized, and vulnerable/disadvantaged individuals;

WHEREAS, the Local Government Unit of Lingayen through the Municipal Social Welfare and Development Office (MSWDO) has formulated the implementing guidelines to govern the implementation of the AICS in the Municipality, in accordance with Memorandum Circular No. 02, S-2014 of the DSWD Central Office;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem, duly seconded by SBM Ricardo R. Ferrer, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to adopt the implementing Guidelines formulated by the MSWDO to carry out the AICS Program in the Municipality of Lingayen.

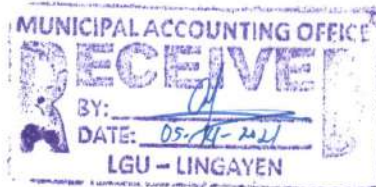
