THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on May 17, 2021, at Lingayen, Pangasinan, the following resolution was approved.

RESOLUTION NO. 429, S-2021

DECLARING BARANGAY TAX ORDINANCE NO. 1, S-2021 OF THE SANGGUNIANG BARANGAY OF DOMALANDAN EAST, LINGAYEN, PANGASINAN, ENTITLED, "AN ORDINANCE ENACTING THE REVISED BARANGAY OMNIBUS TAX CODE OF BARANGAY DOMALANDAN EAST, LINGAYEN, PANGASINAN AND PROVIDING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, the Sangguniang Barangay of Domalandan East, Lingayen, Pangasinan, submitted its Barangay Tax Ordinance No. 1, S-2021 to the Sangguniang Bayan for review and evaluation pursuant to Section 447 (A) (1) (i) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Human Rights of the Sangguniang Bayan of Lingayen have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 391 (a) (1) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Barangay Council of Domalandan East shall cause the posting of this ordinance in at least two (2) conspicuous places in the barangay in pursuance to Section 59 (a) of R.A. 7160;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Mac Dexter G. Malicdem, it was:

RESOLVED AS IT IS HEREBY RESOLVED, to declare Barangay Tax Ordinance No. 1, S-2021 of the Sangguniang Barangay of Domalandan East, Lingayen, Pangasinan, entitled "An ordinance enacting the revised Barangay Omnibus Tax Code of Barangay Domalandan East, Lingayen, Pangasinan and providing penalties thereof" as within the conferred powers of the Sangguniang Barangay to enact.
