RESOLUTION NO. 432, S-2021

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL, TO ENTER INTO AN AGREEMENT WITH THE PHILIPPINE VETERAN'S BANK TO AVAIL OF PAYROLL FACILITY AND SERVICES BY-WAY-OF AUTOMATED TELLER MACHINE (ATM) FOR THE JOB ORDER EMPLOYEES OF THE MUNICIPALITY OF LINGAYEN, AND THE INSTALLATION OF OFF-SITE ATM.

WHEREAS, Section 22 (c) of R.A. 7160, otherwise known as the Local Government Code of 1991 provides that "no contract maybe entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned";

WHEREAS, Section 444 (b) (1) (vi) of the same Code states that for efficient, effective and economical governance, the Municipal Mayor shall "upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents made pursuant to law or ordinance";

WHEREAS, the Philippine Veteran's Bank (PVB), is an authorized government depository bank pursuant to Section 5 of Republic Act No. 7169, which offers cash management products and services including Payroll Facility and Services with rules and terms beneficial to the interest of the municipal government;

WHEREAS, the Municipal Legal Officer, after a thorough evaluation of the terms and conditions stipulated in the Memorandum of Agreement, finds no disadvantage over the stipulations stated therein and the proposed agreement to be in order;

WHEREAS, the Payroll Facility and Services thru ATM will provide an efficient and secure mode of receiving and withdrawing wages for the Job Order Employees of the municipality;

WHEREAS, after due deliberation, the Sangguniang Bayan of Lingayen found the proposals of Philippine Veteran's Bank meritorious and beneficial to the municipality;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor, Honorable Leopoldo N. Bataoil to enter into an agreement with the Philippine Veteran's Bank to avail of Payroll Facility and Services by-way-of Automated Teller Machine (ATM) for the Job Order employees of the Municipality of Lingayen, and the installation of off-site ATM.
