THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on May 31, 2021, at Lingayen, Pangasinan, the following resolution was approved.

RESOLUTION NO. 440, S-2021

DECLARING BARANGAY ORDINANCE NO. 005, S-2020 OF THE SANGGUNIANG BARANGAY OF MALIMPUEC, LINGAYEN, PANGASINAN, ENTITLED, "AN ORDINANCE REGULATING ALL TYPES OF MOTOR VEHICLES WHICH HAVE MODIFIED AFTERMARKET PIPES/MUFFLERS OR SWAPPING OUT OF THE STOCK PIPES/MUFFLERS RESULTING TO THE EMISSION OF EXCESSIVE AND UNREASONABLE LOUD NOISE AND PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, the Sangguniang Barangay of Malimpuec, Lingayen, Pangasinan, submitted its Barangay Ordinance No. 005, S-2020 to the Sangguniang Bayan for review and evaluation pursuant to Section 447 (A) (1) (i) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Human Rights of the Sangguniang Bayan of Lingayen have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 391 (a) (1) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Barangay Council of Malimpuec shall cause the posting of this ordinance in at least two (2) conspicuous places in the barangay in pursuance to Section 59 (a) of R.A. 7160;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Ricardo R. Ferrer, it was:

RESOLVED AS IT IS HEREBY RESOLVED, to declare Barangay Ordinance No. 005, S-2020 of the Sangguniang Barangay of Malimpuec, Lingayen, Pangasinan, entitled "An ordinance regulating all types of motor vehicles which have modified aftermarket pipes/mufflers or swapping out of the stock pipes/mufflers resulting to the emission of excessive and unreasonable loud noise and providing penalties for violation thereof and for other purposes" as within the conferred powers of the Sangguniang Barangay to enact.
