AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL TO SUBSCRIBE TO THE LANDBANK OF THE PHILIPPINES INTERNET PAYMENT FACILITY KNOWN AS “LINK.BIZPORTAL”.

WHEREAS, the Land Bank of the Philippines (LANDBANK) Link.BizPortal is an e-payment facility that allows clients to pay for products and services via Internet from both the government and private institutions/sectors;

WHEREAS, the LANDBANK Link.BizPortal aims to:

- 1) Provide convenience and efficiency to all involved institutions as well as safer and faster delivery of funds;
- 2) Decrease the direct and indirect costs associated with physical cash or distribution of in-kind goods;
- 3) Establish accountability and tracking of financial flows, resulting in less corruption and theft; and
- 4) De-clog lobby traffic and save on operation costs.

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Jasper S. Pasion, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Hon. Leopoldo N. Bataoil in his capacity as Municipal Mayor of Lingayen to:

- 1) Subscribe to the Land Bank of the Philippines internet banking facility known as “Link.BizPortal” and to open an account for this purpose;
- 2) Designate authorized signatory to enroll and designate authorized user/s in the LANDBANK Link.BizPortal;
- 3) Execute/sign all documents necessary to subscribe to the LANDBANK Link. BizPortal; and

- 4) Designate/authorize personnel to act as "user" for the LGU's access to LANDBANK's Link.BizPortal's Merchant Payment Inquiry.
