THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on July 05, 2021, at Lingayen, Pangasinan, the following resolution was approved.

RESOLUTION NO. 458, S-2021

DECLARING BARANGAY ORDINANCE NO. 1, S-2020 OF THE SANGGUNIANG BARANGAY OF LASIP, LINGAYEN, PANGASINAN, ENTITLED, "AN ORDINANCE AUTHORIZING THE MUNICIPALITY OF LINGAYEN TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTION SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITION HEREUNDER" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, the Sangguniang Barangay of Lasip, Lingayen, Pangasinan, submitted its Barangay Ordinance No. 1, S-2020 to the Sangguniang Bayan for review and evaluation pursuant to Section 447 (Å) (1) (i) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Human Rights of the Sangguniang Bayan of Lingayen have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 391 (a) (1) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Barangay Council of Lasip shall cause the posting of this ordinance in at least two (2) conspicuous places in the barangay in pursuance to Section 59 (a) of R.A. 7160;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Ramon Anselmo M. Cuaresma, it was:

RESOLVED AS IT IS HEREBY RESOLVED, to declare Barangay Ordinance No. 1, S-2020 of the Sangguniang Barangay of Lasip, Lingayen, Pangasinan, entitled "An ordinance authorizing the Municipality of Lingayen to issue Barangay Clearance and collect corresponding Barangay Clearance Fee in the application for any business related transaction subject to the remittance of the aforesaid fees to the barangay and the condition hereunder" as within the conferred powers of the Sangguniang Barangay to enact.
