**REQUESTING MAYOR LEOPOLDO N. BATAOIL OF THE MUNICIPALITY OF LINGAYEN TO GRANT FIVE HUNDRED (P500.00) PESOS HONORARIUM TO ALL BARANGAY HEALTH WORKERS (BHWs) IN LINGAYEN AS INCENTIVE IN PERFORMING THEIR FUNCTIONS.**

WHEREAS, Republic Act No. 7160, Section 458 (a) mandates that the Local Government Units shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the code;

WHEREAS, Barangay Health Workers play a pivotal part in the delivery of basic health services in the barangays, and in recognition of their faithful service they are entitled to additional incentives and benefits as provided for under Republic Act No. 7883;

WHEREAS, BHWs are already receiving honorariums from their respective Barangay Councils but is not enough to cover their basic necessities in performing their functions like meals and transportation;

WHEREAS, considering the difficulty and hazards of their job as health service front liners, the hardworking BHWs of Lingayen need more to meet the demands of their work;

WHEREAS, the grant of additional honorarium to BHWs will encourage them to perform more in providing better health service and in raising health awareness in their communities;

WHEREFORE, on motion of SBM Randall Q. Bernal duly seconded by all, be it:
