RESOLUTION NO. 483, S-2021

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL, TO UTILIZE THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P200,000.00) FROM THE PUBLIC AFFAIRS FUND TO AUGMENT THE EXPENSES FOR THE LINGAYEN ART COMPETITION IN CELEBRATION OF THE NATIONAL TOURISM MONTH.

WHEREAS, Tourism is an important engine to the country's economic growth and development;

WHEREAS, to highlight its importance to a country's economic aspirations, the month of September has been declared as Tourism Month to foster awareness on its socio, cultural, political and economic value and contribution in nation building;

WHEREAS, to help boost the local economy which has been affected by the Corona Virus crisis, the Municipal Government thought of undertaking a tourism initiative called "*Lingawen* Lingayen Art Competition" that will be open to all Pangasinenses in painting and drawing categories with the theme "all about Lingayen";

WHEREAS, the project is aimed at motivating budding artists from Pangasinan to develop their creative skills through the depiction of still images of the town in an effort to revitalize local tourism by enticing visitors to come explore the beautiful historic town of Lingayen and experience its natural beauty and wonderful transformation;

WHEREAS, winning artworks will be displayed at the Limahong Tourism Center for viewing by the general public as part of its art collection;

WHEREAS, in the absence of budgetary allocation for the said purpose, there is a need to authorize the Municipal Mayor to use the budget for Public Affairs Fund to augment the expenses to be incurred in the contest which shall cover cash prizes, honorarium of judges, award materials, panel boards, etc.;


WHEREFORE, on motion of SBM Randall Q. Bernal, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor, Honorable Leopoldo N. Bataoil, to utilize the amount of Two Hundred Thousand Pesos (₱200,000.00) to augment the expenses for the Lingayen Art Competition in celebration of the National Tourism Month;
