RESOLUTION NO. 488, S-2021

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT-I (DOH CDH-I), REPRESENTED BY DR. VALERIANO JESUS V. LOPEZ, RELATIVE TO THE EXPANSION/UPGRADING OF THE LINGAYEN RURAL HEALTH UNIT.

WHEREAS, the State recognizes its mandate to provide equitable and accessible quality healthcare for all Filipinos;

WHEREAS, faced with the coronavirus pandemic that is affecting the world, Lingayen is enhancing its defense by upscaling its health facilities, workforce, and medical equipment to effectively manage the crisis;

WHEREAS, pursuant to the government's mandate on Universal Health Care, the Department of Health (DOH) commits to achieve over-all health system goals of improved health outcomes, financial risk protection and responsiveness;

WHEREAS, as partners of Local Government Units, the DOH is committed thru the Health Facilities Enhancement Program (HFEP) in providing assistance to government owned facilities for improvement of structure, equipment upgrades, medical transportation such as mobile vans and ambulances, and acquisition of land for health facility expansion;

WHEREAS, the DOH thru the HFEP for Calendar Year 2021 has appropriated the amount of Two Million Pesos (₱ 2,000,000.00) intended for the expansion/upgrading of the Lingayen Rural Health Unit for implementation and procurement by the Local Government Unit thru transfer of fund;

WHEREAS, Section 444 (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Municipal Mayor upon authorization by the Sangguniang Bayan shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the August Body found the stipulations in the MOA in order;

WHEREFORE, on motion of SBM Ramon Anselmo M. Cuaresma, duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor to enter into a Memorandum of Agreement (MOA) with the Department of Health Center for Health Development-I (DOH CDH-I), represented by Dr. Valeriano Jesus V. Lopez, relative to the expansion/upgrading of the Lingayen Rural Health Unit.


