RESOLUTION NO. 49, S-2019

AUTHORIZING THE MUNICIPAL MAYOR, HON. LEOPOLDO N. BATAOIL TO DEMOLISH THE UNCLE SAM RESTAURANT AND JEFFREY'S RESTAURANT LOCATED AT THE RIZAL PARK, FOR THE REHABILITATION AND BEAUTIFICATION OF THE DELA CRUZ AUDITORIUM AND RIZAL PARK, THIS MUNICIPALITY.

WHEREAS, the Municipal Government of Lingayen signified its intention to rehabilitate and beautify the Dela Cruz Auditorium and Rizal Park thru a communication addressed to the Audit Team Leader of Lingayen requesting for approval to undertake demolition of the existing structures situated in the said premises;

WHEREAS, prior to the plan to demolish, the proprietor of Uncle Sam, Ms. Bella Santos voluntarily surrendered her ownership and possession of the said structure to the municipality on account of expiration of lease contract, and Engr. Federick C. Teodoro relinquished his claims to the Jeffrey's Restaurant in favor of the municipality;

WHEREAS, in reply to the letter of the good Mayor, the Audit Team Leader of Lingayen requested for an authorization from the Sangguniang Bayan of Lingayen;

WHEREAS, upon scrutiny and evaluation of the documents provided supporting the rehabilitation and beautification plans, the Council unanimously agreed to issue the authorization to the Local Chief Executive in support of his laudable programs;

WHEREAS, for the interest of the greater number of people in Lingayen, the Rizal Park being a public property must be beyond the commerce of man;

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor, Hon. Leopoldo N. Bataoil to demolish the Uncle Sam Restaurant and Jeffrey's Restaurant located at the Rizal Park, for the rehabilitation and beautification of the Dela Cruz Auditorium and Rizal Park, this municipality.
