APPLYING TO THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT I, REPRESENTED BY DIR. VALERIANO JESUS V. LOPEZ, MD, MPH, MHA, CESO IV, DIRECTOR IV, FOR THE ISSUANCE OF PERMIT TO CONSTRUCT (PTC) OF THE BIRTHING FACILITY AND EXPANSION OF RHU AT SOUTHERN MUNICIPAL DISTRICT OF LINGAYEN.

WHEREAS, pregnant or about to deliver women from the Southern Municipal District of Lingayen are prone to deliver their babies at home due to its far geographical distance from the nearest hospital;

WHEREAS, to remedy and prevent home delivery, the Rural Health Unit (RHU) of Southern Lingayen intends to construct a birthing facility that will require a PTC from the Department of Health (DOH);

WHEREAS, one of the requirements for the application of PTC is a Sangguniang Bayan Resolution to effect its establishment;

WHEREAS, this August body deems it necessary to enact a resolution applying to the Department of Health-Center for Health Development I represented by Dir. Valeriano Jesus V. Lopez, MD, MPH, MHA, CESO IV, DIRECTOR IV, for the issuance of Permit To Construct (PTC) of the RHU Southern Lingayen with the following barangays to serve, namely: Aliwekwek, Basing, Dulag, Lasip, Malawa, Matalava, Naguelguel, Quibaol, Rosario, Talogtog, Tumber, and Wawa of this municipality;

WHEREFORE, on motion of SB Member Mac Dexter G. Malicdem duly seconded by SB Members Jay Mark Kevin D. Crisostomo and Randall Q. Bernal, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to apply to Department of Health-Center for Health Development I, represented by Dir. Valeriano Jesus V. Lopez, MD, MPH, MHA, CESO IV, DIRECTOR IV, for the issuance of Permit to Construct (PTC) of the Birthing Facility and expansion of RHU at southern municipal district of Lingayen.


