**RESOLUTION NO. 493, S-2021**

**REQUESTING PHILIPPINE RED CROSS CHAIRMAN, SENATOR RICHARD "DICK" J. GORDON TO DONATE ISOLATION TENTS FOR THE MUNICIPALITY OF LINGAYEN TO BE USED IN THE SCHOOL CONVERTED MUNICIPAL ISOLATION FACILITY.**

WHEREAS, COVID-19 cases in Pangasinan has been spiraling for several weeks now and it has caused great alarm to the officials and constituents of this great province;

WHEREAS, COVID Care Units of hospitals in the province have reached full capacity prompting the Local Government Unit (LGU) of Lingayen to identify locations to serve as possible isolation areas;

WHEREAS, at present, the Municipal Government has only one (1) Isolation Facility for confirmed COVID-19 positive cases which can only cater 14 people, hence the need for an additional facility;

WHEREAS, the local government has positively identified Lingayen I Central School in Barangay Maniboc as an ideal site suitable for conversion into an Isolation Facility because of its big rooms which could accommodate a total of 36 people - and spacious school premises;

WHEREAS, the school converted Isolation Facility shall be manned and monitored by official LGU doctor/s and medical personnel who will take care of the individuals who have contracted COVID-19 with mild symptoms until they can safely return to their homes;

WHEREAS, the Philippine Red Cross (PRC) has been assisting LGUs in setting-up isolation facilities in schools to prevent hospitals from being overwhelmed with COVID-19 cases and to help address the health pandemic in the country;

WHEREAS, the provision of tents by the PRC shall help the municipality curb the spread of the virus by providing the sick with essential health care services, thereby protecting the overall well-being of its constituents;

WHEREFORE, on motion of Vice Mayor Judy DL. Vargas-Quiocho, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Philippine Red Cross Chairman, Senator Richard "Dick" J. Gordon to donate isolation tents for the Municipality of Lingayen to be used in the school converted Municipal Isolation Facility.

RESOLVED FURTHER, that a copy of this Resolution be furnished to PRC Chairman, Senator Richard "Dick" J. Gordon, Boni Avenue, Mandaluyong City, for his information and favorable action.
