RESOLUTION NO. 499, S-2021

AUTHORIZING THE HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ACCEPT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF LINGAYEN THE DONATION OF ONE (1) UNIT PATIENT TRANSPORT VEHICLE FROM THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT-I AND TO SIGN THE DEED OF DONATION AND OTHER PERTINENT DOCUMENTS RELATIVE THERETO.

WHEREAS, the State recognizes its mandate to provide equitable and accessible quality healthcare for all Filipinos;

WHEREAS, The Department of Health's Program "Boosting Universal Health Care via FOURmula One Plus or F1 Plus" envisions quality health care to be more accessible to the poor and vulnerable population by ensuring the availability of functional health care facilities;

WHEREAS, the Health Facilities Enhancement Program (HFEP) aims to improve the delivery of health services through the upgrading of health facilities and provision of medical equipment in order to make them more responsive to the health needs of the population;

WHEREAS, Section 16 of the Local Government Code states that it is the duty of the Local Government Unit (LGU) to promote the health and safety of the people within its territorial jurisdiction and the public in general;

WHEREAS, the Municipality of Lingayen and the Department of Health (DOH) are partners in implementing health programs for the delivery of quality health services; and in the spirit of goodwill, assistance and generosity, the DOH freely donated to the municipality one (1) unit of Patient Transport Vehicle

amounting to One Million Four Hundred Eighty Five Thousand Pesos (P1,485,000.00);

WHEREAS, one of the requirements to effectuate the said donation is a Sangguniang Bayan resolution authorizing the Local Chief Executive to receive the vehicle and to sign for and in behalf of the municipality the Deed of Donation and other pertinent documents relative thereto with the DOH Center for Health Development-I represented by Dir. Valeriano Jesus V. Lopez, MD, MPH, MHA, CESO IV;

WHEREAS, the provision of said Patient Transport Vehicle shall enhance the LGU health system and the delivery of quality health care and services to people in need of immediate medical assistance;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem, duly seconded by SBM Randall Q. Bernal, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Honorable Mayor Leopoldo N. Bataoil to accept on behalf of the Municipal Government of Lingayen the donation of one (1) unit Patient Transport Vehicle from the Department of Health Center for Health Development-I and to sign the Deed of Donation and other pertinent documents relative thereto.
