RESOLUTION NO. 05, S-2019

REQUESTING SENATE PRESIDENT VICENTE C. SOTTO III TO ALLOCATE FUNDS FOR THE UPGRADING OF THE LINGAYEN AIRPORT.

WHEREAS, the Lingayen Airport is located at the town proper of Lingayen, parallel to the beach running roughly east to west along Lingayen Gulf which was also known as "Lingayen Aerodrome" or "Lingayen Field" during World War II and was used by the US pilots flying familiarization flights in North Luzon and contingent of Philippine Army;

WHEREAS, the Lingayen Airport is classified as community airport by the Civil Aviation Authority of the Philippines which was built by the Americans in 1945 serving the general area of Lingayen;

WHEREAS, the Lingayen Airport has a total land area of 10.4 hectares which caters only small aircraft, usually flight training planes for students from aviation schools;

WHEREAS, it is the vision of the present administration headed by Mayor Leopoldo N. Bataoil, Vice Mayor Judy D. Vargas and the Sangguniang Bayan Members to have an airport which can accommodate commercial flights;

WHEREAS, the upgrading of the Lingayen Airport like the improvement of perimeter fence, construction of bay fire station building, construction of staff house, the asphalt overlay of the runway and other upgrading projects will establish the Lingayen Airport as one of the premier airport in the country;
