RESOLUTION NO. 504, S-2021

AUTHORIZING HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) FOR THE IMPLEMENTATION OF DOLE-EMERGENCY EMPLOYMENT PROGRAM UNDER TUPAD (TULONG PANGHANAPBUHAY SA ATING DISPLACED/DIADVANTAGED WORKERS PROGRAM) AND PROVIDING EQUITY OF AT LEAST 20% OF THE TOTAL PROJECT COST.

WHEREAS, in pursuance to the mandate of DOLE to implement social protection programs, projects and services, the agency initiated the Tulong Panghanapbuhay sa Ating Displaced/Disadvantaged Workers Program or TUPAD to mitigate the adverse economic impacts of the COVID-19;

WHEREAS, both the DOLE and the Local Government Unit of Lingayen aims to promote emergency employment opportunities to the displaced informal sector workers of Lingayen whose employment was disrupted and affected due to the continuing effects of the COVID-19 global pandemic;

WHEREAS, the Municipal Government of Lingayen agreed to support the said program for the benefit and interest of its constituents who are in dire need of jobs and economic relief;

WHEREAS, the Municipal Government of Lingayen shall provide an equity of at least 20% of the total project cost as its counterpart in the form of facilities, tools, equipment and the like;

WHEREAS, the Municipal Government of Lingayen has been accredited by DOLE to be capable of implementing the TUPAD Program;

WHEREFORE, on motion of VM JUDY DL. VARGAS-QUIOCHO, duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Honorable Mayor Leopoldo N. Bataoil to enter into a Memorandum of Agreement (MOA) with the Department of Labor and Employment (DOLE) for the implementation of DOLE-Emergency Employment Program under TUPAD (Tulong Panghanapbuhay sa Ating Displaced/Disadvantaged Workers Program) and providing equity of at least 20% of the total project cost.

RESOLVED FURTHER, that copies of this resolution be furnished to Atty. Evelyn R. Ramos, Regional Director of DOLE Regional Office I, San Fernando City, La Union, and the Municipal Mayor, Hon. Leopoldo N. Bataoil, for their information and guidance.
