REQUESTING THE MUNICIPAL MAYOR, HON. LEOPOLDO N. BATAOIL, TO GRANT FIVE HUNDRED (P500.00) PESOS MONTHLY GASOLINE ALLOWANCE TO ALL BARANGAY CAPTAINS OF LINGAYEN, PANGASINAN.

WHEREAS, the Liga ng mga Barangay of Lingayen conducts a monthly meeting every second Thursday of the month held at the ABC Hall, Municipal Building, Lingayen, Pangasinan;

WHEREAS, every trip to the Municipal Town Hall entails transportation and gasoline expense on the part of the Barangay Captains;

WHEREAS, considering the frequent increase in fuel and fare and the rise in vehicle spare parts, the Barangay Captains are feeling burdened in going about their duties and functions in their respective barangays, and in attending meetings and seminars called by the DILG, Governor, Mayor and the Liga President;

WHEREAS, to encourage the Barangay Captains to be more effective and productive, the gasoline allowance will serve as their incentive to perform much better as barangay chief;

WHEREAS, in claiming said benefit, only those who attended the monthly meeting shall be allowed to collect their gas allotment for the month;

WHEREFORE, on joint motion of SBM Darwin B. Jimenez and SBM Ramon Anselmo M. Cuaresma duly seconded by all, be it:

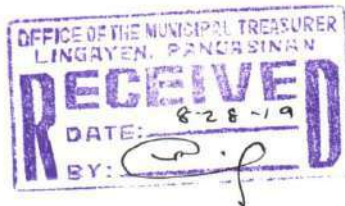


