**RESOLUTION NO. 510, S-2021**

**A RESOLUTION REQUESTING HONORABLE GOVERNOR AMADO "POGI" I. ESPINO, III FOR MONO-BLOC CHAIRS TO BE DISTRIBUTED TO 32 BARANGAYS OF LINGAYEN, PANGASINAN.**

WHEREAS, Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", Chapter II, Section 17, emphasizes the need of the local government to ensure the provision of basic services and facilities;

WHEREAS, Lingayen Barangay Officials see the need to have adequate equipment that they can use - such as mono-bloc chairs - for the convenience and comfort of their residents during community meetings/gatherings and other related activities;

WHEREAS, said objective is a priority project of each barangay, however it cannot be realized due to their insufficient funds;

WHEREAS, 32 barangays in Lingayen have been therefore appealing for mono-bloc chairs from the Local Government of Lingayen;

WHEREAS, the Municipality had already allocated its resources to other purposes, thus hindering the procurement of such needed items for the barangays;

WHEREAS, as there is no appropriation for this project, the local government is seeking the assistance of the Provincial Governor who is known for his benevolence and magnanimity especially to the people of the barangays;

WHEREAS, the Provincial Governor, as the Chief Executive of the Provincial Government, is mandated to exercise powers and perform duties necessary to promote the general welfare of its inhabitants;

WHEREFORE, on motion of SBM Randall Q. Bernal, duly seconded by SBMs Jay Mark Kevin D. Crisostomo and Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Honorable Governor Amado "Pogi" I. Espino, III for mono-bloc chairs to be distributed to 32 barangays of Lingayen, Pangasinan
