RESOLUTION NO. 511, S-2021

REQUESTING HONORABLE GOVERNOR AMADO "POGI" I. ESPINO, III FOR BAGS OF CEMENT TO BE DISTRIBUTED TO 32 BARANGAYS OF LINGAYEN, PANGASINAN.

WHEREAS, infrastructure development is one of the primary objectives of the Local Government intended primarily to service the needs of its constituency - pursuant to Section 16 of the Local Government Code of 1991;

WHEREAS, cement is an essential component in realizing any infrastructure development geared towards a better community;

WHEREAS, Lingayen Barangay Officials also see cement as an imperative tool to any construction intended to provide basic services for the people; such as building and/or maintaining infrastructure facilities e.g. barangay halls, barangay roads, multi-purpose halls, multi-purpose pavement, barangay plazas, barangay sports centers, and other similar facilities;

WHEREAS, the purchase of cement is within the limits of the capability of barangay budget allocations;

WHEREAS, 32 barangays in Lingayen have been therefore seeking assistance from the Local Government to provide bags of cement;

WHEREAS, the Municipality had already allocated its funding to other purposes, thus hindering the procurement of such needed items for the barangays;

WHEREAS, as there is no appropriation for this endeavor, the Honorable Council is relying on the benevolence and generosity of the good Provincial Governor whose love for the people of the barangays is beyond doubt;

WHEREAS, the Provincial Governor, as the Chief Executive of the Provincial Government, is mandated to exercise powers and perform duties necessary to promote the general welfare of its inhabitants;

WHEREFORE, on motion of SBM Randall Q. Bernal, duly seconded by SBMs Jay Mark Kevin D. Crisostomo and Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Honorable Governor Amado "Pogi" I. Espino, III for bags of cement to be distributed to 32 barangays of Lingayen, Pangasinan

RESOLVED FURTHER, that a copy of this resolution be furnished to the Honorable Governor Amado "Pogi" I. Espino, III for his information and appropriate action.
