BATAOIL TO TRANSFER THE MULTI-PURPOSE EVACUATION CENTER LOCATED AT THE VICINITY OF THE DELA CRUZ AUDITORIUM TO THE RECLAIMED AREA, NEAR THE MDRRMC BUILDING, TO GIVE WAY FOR THE REHABILITATION AND BEAUTIFICATION EFFORTS TO BE UNDERTAKEN AT THE DELA CRUZ AUDITORIUM, THIS MUNICIPALITY.**

WHEREAS, the Dela Cruz Auditorium is an important landmark in the municipality where important events such as the Town Fiesta, Agew na Poblacion and the Bagoong Festival are held;

WHEREAS, one of the priority projects of the LGU leadership is to refurbish the town plaza to help boost tourism and commerce and to promote order and cleanliness in the public square that could increase the quality of life of every Lingayenense;

WHEREAS, the Multi-Purpose Evacuation Center needs to be relocated to give way to the rehabilitation and beautification efforts intended for the area; thus finding an appropriate place for its purpose and function;

WHEREAS, the renovation is expected to spark economic development in the municipality and attract more tourists to come and visit the beautiful and historic town of Lingayen;
