**RESOLUTION NO. 532, S-2021**

**AUTHORIZING THE GRANT OF ADDITIONAL TWO HUNDRED FIFTY PESOS (P250.00) MONTHLY TRAVELLING ALLOWANCE TO ALL BARANGAY SERVICE POINT OFFICERS (BSPOs) OF LINGAYEN, PANGASINAN.**

WHEREAS, BSPOs are barangay-based volunteer workers tasked to promote and widen awareness of government's family planning and reproductive health services as well as health and livelihood opportunities education in the community;

WHEREAS, BSPOs conduct programs on responsible parenthood and family planning, and gathering/collecting up-to-date demographic and population data at the barangay level;

WHEREAS, BSPOs are classified as front liners who help ensure the effective local management and response on COVID-19 in their communities by serving as members of Barangay Health Emergency Response Teams (BHERTs) in their respective barangays, and providing access to family planning information and services as well as sexual and reproductive health;

WHEREAS, there are 34 BSPOs in Lingayen currently receiving Two Hundred Fifty Pesos (P250.00) monthly travelling allowance who are working full swing in helping raise public awareness on the Local Government Unit's (LGU's) Inoculation Program;

WHEREAS, considering the prevailing high cost of transportation expense and the crucial roles of BSPOs in the LGU's pandemic response, an increase in their monthly travelling allowance is deemed justified in recognition of their role in the implementation of various municipal programs;






