EXPRESSING STRONG SUPPORT FOR THE PROCUREMENT OF THIRTY-TWO (32) UNITS OF SERVICE VEHICLES BY THE MUNICIPAL GOVERNMENT FOR THE THIRTY-TWO (32) BARANGAYS OF LINGAYEN, PANGASINAN.

WHEREAS, some barangays in the municipality have no service vehicles which they can use in speeding up delivery of basic services;

WHEREAS, others have old service vehicles which often times need repair and maintenance which is taxing on the part of the barangay considering their minimal budget allocations;

WHEREAS, the service vehicles to be procured will be used in times of medical emergencies, rescue, relief operations, other social humanitarian needs, and various official transactions;

WHEREAS, the barangays do not have sufficient funds for the purchase of their own service vehicles;

WHEREAS, the Municipal Government of Lingayen has allocated funds for the said purpose in the 2022 Annual Executive Budget;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem, duly seconded by SBM Ricardo R. Ferrer, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to express strong support for the procurement of Thirty-Two (32) units of Service Vehicles by the Municipal Government for the Thirty-Two (32) Barangays of Lingayen, Pangasinan.


RESOLVED FURTHER, that a copy of this resolution be furnished the
