RESOLUTION NO. 538, S-2021

AUTHORIZING THE HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ACCEPT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF LINGAYEN THE DONATION OF ONE (1) UNIT PATIENT TRANSPORT VEHICLE FROM THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) AND TO SIGN THE DEED OF DONATION AND OTHER PERTINENT DOCUMENTS RELATIVE THERETO.

WHEREAS, the State recognizes its mandate to provide equitable and accessible quality healthcare for all Filipinos;

WHEREAS, the PCSO Patient Transport Vehicle (PTV) Program refers to the provision of medical transport vehicles to Local Government Units (LGUs) at the provincial, municipal and city located in conflict-stricken areas and vulnerable communities, and those geographically isolated and disadvantaged areas to enhance the delivery of emergency health services to the public;

WHEREAS, through the provision of PTV, PCSO intends to help LGUs, and government hospitals and institutions by transporting patients to or from hospitals or between places of treatment, giving them access to immediate medical service;

WHEREAS, Section 16 of the Local Government Code states that it is the duty of the LGU to promote the health and safety of the people within its territorial jurisdiction and the public in general;

WHEREAS, the Municipality of Lingayen and the PCSO are partners in implementing health programs for the delivery of quality health services; and in the spirit of goodwill, assistance and generosity, the PCSO freely donated one (1) unit of PTV to the municipality as part of its charity-oriented thrusts which the LGU is most appreciative of;

WHEREAS, one of the requirements to effectuate the said donation is a Sangguniang Bayan resolution authorizing the Local Chief Executive to receive the vehicle and to sign for and in behalf of the municipality the Deed of Donation and other pertinent documents relative thereto with the PCSO represented by Vice Chairperson and General Manager, Royina Marzan Garma;

WHEREAS, the provision of said PTV shall enhance the LGU health system and the delivery of quality health care services to people in need of immediate medical assistance especially in this time of pandemic;




