RESOLUTION NO. 54-A, S-2019

A RESOLUTION ADOPTING REPUBLIC ACT NO. 10176, AN ACT REVIVING THE OBSERVANCE OF ARBOR DAY BY AUTHORIZING THE LOCAL GOVERNMENT UNITS THE RESPONSIBILITIES FOR CELEBRATING THE DAY FOR TREE PLANTING AS AN ANNUAL EVENT, OTHERWISE KNOWN AS THE "ARBOR DAY ACT OF 2012".

WHEREAS, pursuant to Republic Act No. 10176, it is hereby mandated that all provinces, cities and municipalities with their component barangays shall be required to revive, by appropriate proclamation of their respective Local Chief Executives, an Arbor Day at an appropriate fixed date every calendar year as shall be deemed suitable according to the proper time and season for planting trees in their respective jurisdictions;

WHEREAS, the observance of Arbor Day is in consonance with the declared policy of the State to protect and advance the right of the people to a balanced and healthful ecology;

WHEREAS, the planting of trees in their respective jurisdiction is to combat the loss of our natural resources in order to rejuvenate our environment and providing effective measures for their maintenance and sustainability;
