RESOLUTION NO. 543, S-2021

REQUESTING THE HON. LEOPOLDO N. BATAOIL, MUNICIPAL MAYOR, LINGAYEN, PANGASINAN, TO ALLOCATE FUNDS FOR THE TRAVELLING ALLOWANCE OF THE FEDERATED PRESIDENT OF PERSONS WITH DISABILITY (PWD) AMOUNTING TO FIVE THOUSAND PESOS (P5,000.00) A MONTH, AND THE BARANGAY PWD PRESIDENTS AMOUNTING TO ONE THOUSAND PESOS (P1,000.00) A MONTH, TO FUND THEIR EXPENSES IN PERFORMING THEIR TASKS.

WHEREAS, Republic Act No. 7277, otherwise known as the Magna Carta for Disabled PWDs are essential members of the society and must be accorded the same rights and privileges as the others; hence the State is mandated to give them full support to enhance their well-being and allow their integration to mainstream society;

WHEREAS, the same act provides for the rehabilitation, self-development and self-reliance of disabled persons and articulates the prohibition on discrimination of PWDs;

WHEREAS, Batas Pambansa Blg. 344 or the Accessibility Law, ratified on December 7, 1982 is an act enhancing the mobility of disabled persons that requires buildings, institutions, establishments and public utilities to install some facilities and other devices as well as the installation of sidewalks, ramps and railings for the PWDs in public places;

WHEREAS, Republic Act. No. 10754, signed on December 01, 2016 is an expansion of the benefits and privileges of PWDs in the Philippines as an amendment to the Magna Carta for Disabled Persons which highlights the basic and societal benefits and privileges of PWDs;

WHEREAS, Article 4.3 of the United Nations Convention on the Rights of Persons with Disabilities mandates the Philippine Government to closely consult with and actively involve PWDs through their respective organizations in the development and enactment of legislation and formulation of policies to implement this international commitment;

WHEREAS, the Local Government Unit (LGU) of Lingayen through the Municipal Social Welfare and Development Office (MSWDO), adopted policies to govern and ensure the rehabilitation, self-development and the self-reliance of disabled persons; develop their skills and potentials and enable them to compete favorably for available opportunities;

WHEREAS, the organization of PWDs in the LGU's Barangays is a mechanism to reach out to them with the intention of unifying them, encouraging their full participation while integrating them into mainstream society;

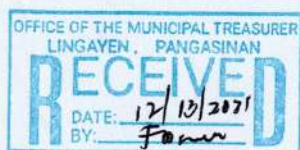
WHEREAS, the leaders, particularly the Presidents of the PWD organizations in the Barangays are wanting in finances to defray their expenses as they perform their functions for their fellow PWDs;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem, duly seconded by SBM Ricardo R. Ferrer, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request the Hon. Leopoldo N. Bataoil, Municipal Mayor, Lingayen, Pangasinan, to allocate funds for the travelling allowance of the Federated President of Persons with Disability (PWD) amounting to Five Thousand Pesos (₱5,000.00) a month and to the Barangay PWD Presidents amounting to One Thousand Pesos (₱1,000.00) a month, to fund their expenses in performing their tasks.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Municipal Mayor, the LGU's Local Finance Committee, the MSWD Officer, Ms. Lorenza Decena, and the Federation President of the PWD barangay organizations of Lingayen for their information and favorable action.

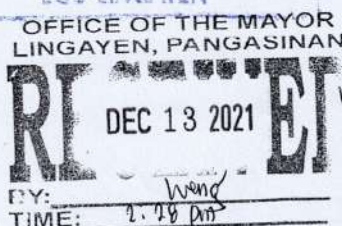
