RESOLUTION NO. 547, S-2021

EXPRESSING FULL SUPPORT TO THE CONSTRUCTION OF THE ELEVATED FOOTBRIDGE WALKWAY AND THE PROPOSED ELEVATED PLAZA PROJECT OF THE MUNICIPAL GOVERNMENT OF LINGAYEN.

WHEREAS, the Sangguniang Bayan (SB) is in receipt of a letter from the Municipal Mayor endorsing for deliberation and legislative action several municipal projects in line with the Development Plan of the Lingayen Town Center;

WHEREAS, cited as one of the priority projects by the Local Government as contained in the Site Development Plan is the construction of the Elevated Footbridge Walkway and the proposed Elevated Plaza that will interconnect the new SB Legislative Hall, Public Market, Plaza, District Hospital, Common Terminal, and Church;

WHEREAS, said Elevated Footbridge Walkway and Plaza was conceived to enhance interconnectivity, functionality and compliance to government policies, and to give the people better access to government with transparency and ease of doing business;

WHEREAS, the structures were designed to give a better and enhanced perspective of the town and its nearby historic buildings like the Casa Real, Provincial Jail, and Stewart Memorial United Methodist Church, and to serve as view deck for locals and tourists alike, perfect for Instagrammable photographs;

WHEREAS, the Elevated Plaza may also be converted as assembly area for flag raising and lowering ceremonies by the municipal officials and employees without disturbing the flow of traffic especially on busy Monday mornings and Friday afternoons;

WHEREAS, it is also the intent of the project to ease traffic congestion in downtown Lingayen particularly in the Plaza, Market and Church areas where people tend to converge for their daily activities;


WHEREFORE, on motion of SBM Jasper S. Pasion, duly seconded by SBM Mac Dexter G. Malicdem, be it:
