**RESOLUTION NO. 550, S-2021**

**CREATING THE LOCAL CULTURAL INVENTORY OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN, AND ENDORSING THE SAME TO THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) IN COMPLIANCE TO THE GUIDELINES GOVERNING THE PHILIPPINE REGISTRY OF CULTURAL PROPERTY (PRECUP).**

WHEREAS, Section 2 of Republic Act 10066, also known as the National Cultural Heritage Act of 2009, mandates the protection, preservation, conservation, and promotion of the nation's cultural heritage, its property histories, and the ethnicity of local communities;

WHEREAS, the law prescribes that the NCCA together with various cultural agencies and local government units to create and maintain the PRECUP which shall serve as the registry of all cultural property of the country deemed of significant importance to cultural heritage;

WHEREAS, the Registry is an important tool and serves as a prerequisite to vigorously pursue the identification, preservation, protection, conservation, safeguarding, and retrieval of Filipino historical and cultural heritage and resources, and as repository of people's dynamic culture to aid in its development, promotion, and dissemination;

WHEREAS, the Local Government Unit of Lingayen has identified cultural properties (tangible and intangible) under its jurisdiction which shall comprise its Inventory of Cultural Property that includes locally significant cultural properties and properties not yet formally declared by the concerned cultural agencies such as National Cultural Treasures, National Historical Landmarks, National Historical Shrines, National Historical Monuments, or Important Cultural Properties;

WHEREAS, said Inventory of documentations shall be submitted to the NCCA for inclusion to the Registry in compliance to the provisions of Resolution No. 2017-330- adopting the guidelines governing the PRECUP;



RESOLVED AS IT IS HEREBY RESOLVED, to create the Local Cultural Inventory of the Municipality of Lingayen, Pangasinan, and endorsing the same to the National Commission for Culture and the Arts (NCCA) in compliance to the guidelines governing the Philippine Registry of Cultural Property (PRECUP).


