THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on September 03, 2019, at Lingayen, Pangasinan, the following resolution was approved.

RESOLUTION NO. 56, S-2019

DECLARING ORDINANCE NO. 9, S-2019 OF THE SANGGUNIANG BARANGAY OF WAWA, LINGAYEN, PANGASINAN, ENTITLED, "AN ORDINANCE PROHIBITING ALL MOTORISTS TO USE ANY MATERIAL THAT CONCEALS IDENTITY IN PUBLIC PLACES WITHIN THE JURISDICTION OF BARANGAY WAWA, LINGAYEN, PANGASINAN", AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, the Sangguniang Barangay of Wawa, Lingayen, Pangasinan, submitted its Ordinance No. 9, S-2019 to the Sangguniang Bayan for review and evaluation pursuant to Section 447 (A) (1) (i) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws of the Sangguniang Bayan of Lingayen have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 391 (a) (1) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;


WHEREAS, the Barangay Council of Wawa shall cause the posting of this ordinance in at least two (2) conspicuous places in the barangay in pursuance to Section 59 (a) of R.A. 7160;

WHEREFORE, on motion of SBM Jonathan Carl R. Arcinue, duly seconded by SBM Jay Mark Kevin D. Crisostomo, it was:

RESOLVED AS IT IS HEREBY RESOLVED, to declare Ordinance No. 9, S-2019 of the Sangguniang Barangay of Wawa, Lingayen, Pangasinan, entitled "An ordinance prohibiting all motorists to use any material that conceals identity in public places within the jurisdiction of Barangay Wawa, Lingayen, Pangasinan", as within the conferred powers of the Sangguniang Barangay to enact.

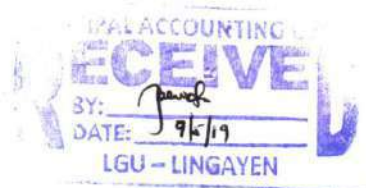
