RESOLUTION NO. 61, S-2019

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL TO DEMOLISH THE COMFORT ROOMS, OLD METAL FRAMES, CONCRETE BENCHES OF THE DELA CRUZ AUDITORIUM TO GIVE WAY FOR THE DEVELOPMENT AND IMPROVEMENT OF THE LINGAYEN PLAZA.

WHEREAS, the Sangguniang Bayan previously passed a resolution authorizing the Municipal Mayor to demolish and transfer the existing Multi-Purpose Evacuation Facility located at the Dela Cruz Auditorium in the Reclaimed Area, near the LDRRMO Building to give way for its rehabilitation and beautification efforts;

WHEREAS, other concrete structures inside the Auditorium like the comfort rooms, old metal frames, concrete benches needs to be likewise demolished to carry out the renovation plans for the plaza;

WHEREAS, the demolition of these structures will give way for the expeditious construction of the Dela Cruz Auditorium in time for the holding of important events like the Town Fiesta and the Bagoong Festival;

WHEREFORE, on motion of SBM John Silvester A. Tapia duly seconded by SBM Ricardo R. Ferrer, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor, Honorable Leopoldo N. Bataoil to demolish the comfort rooms, old metal frames, concrete benches of the Dela Cruz Auditorium to give way for the development and improvement of the Lingayen Plaza.
