### RESOLUTION NO. 62, S-2019

**IMPLEMENTING MEMORANDUM CIRCULAR NO. 2019-121 OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) AND FURTHER AUTHORIZING AND SUPPORTING THE MUNICIPAL MAYOR IN THE CLEARING OPERATION IN ALL PUBLIC ROADS IN THE MUNICIPALITY OF LINGAYEN, PANGASINAN.**

WHEREAS, President Rodrigo Roa Duterte issued a directive during his State of the Nation Address (SONA) to all local officials to exercise their powers to reclaim public roads being used for private ends and rid them of illegal structures and constructions;

WHEREAS, by virtue of DILG Memorandum Circular No. 2019-121, Local Chief Executive are henceforth directed to revoke permits that give authority to private entities to occupy public roads, alleys and thoroughfares;

WHEREAS, Mayors are given 60 calendar days to achieve, document and report significant results and in case of non-compliance, an appropriate administrative case will be filed against the official;

WHEREAS, to ensure full implementation of the Circular, the Sangguniang Bayan signifies its full support and GIVES authority to the Municipal Mayor to undertake the clearing of public roads of all illegal structures and constructions;

WHEREFORE, on motion of SBM John Silvester A. Tapia duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:
