WHEREAS, the renovation will boost the tourism industry of Pangasinan since the Lingayen Municipal Building is considered one of the historical sites of the province and is located very near the Provincial Capitol and the Lingayen Beach which are frequented by locals and tourists alike;

WHEREAS, the municipality has insufficient funds to undertake the project and is relying on the benevolence of the good DPWH Regional Director to fund allocation;
