AUTHORIZING HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH URDANETA WASTE MANAGEMENT FOR THE USE OF THE MATERIAL RECOVERY FACILITY (MRF) AND/OR AT THE URDANETA ENGINEERED SANITARY LANDFILL FACILITY.

WHEREAS, the Municipal Government of Lingayen, a Local Government Unit created and existing by virtue of its Charter and the laws of the Republic of the Philippines, herein represented by its Municipal Mayor, HON. LEOPOLDO N. BATAOIL, pursuant to and in accordance with SB Resolution No. 67, S-2019 of the Sangguniang Bayan of Lingayen, approved on September 30, 2019, with office address at Municipal Hall, Lingayen, Pangasinan, hereinafter to as FIRST PARTY;

WHEREAS, Urdaneta Waste Management, a sole proprietorship with office address at Sitio Calegu, Barangay Catablan, Urdaneta City, Pangasinan, herein represented by its General Manager, Mr. MARK ANTHONY V. AGSALUD, hereinafter referred to as the SECOND PARTY;

WHEREAS, the municipality, in its commitment to have an efficient, economical and effective solid waste management system has considered to have a nearer disposal facility to dispose of its residual solid wastes in order to save time and resources;

WHEREAS, other terms and conditions stipulated in the Memorandum of Agreement (MOA) shall form as an integral part of this resolution;

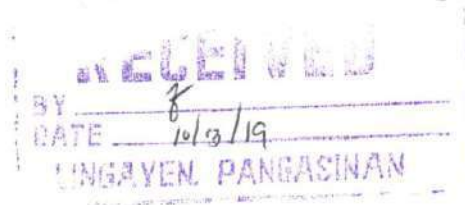
