### **RESOLUTION NO. 69, S-2019**

#### **ADOPTING THE 3 YEAR LOCAL COMPREHENSIVE JUVENILE INTERVENTION PROGRAM OF THE MUNICIPALITY OF LINGAYEN FOR THE YEAR 2019-2022.**

WHEREAS, presented for consideration to the Sangguniang Bayan is the Comprehensive Local Juvenile Program (CLJIP) of the Municipality of Lingayen for FY 2019-2022 as endorsed by the Lingayen Council for the Welfare and Protection of Children;

WHEREAS, the Local Government Code of 1991 mandates all local government units to promote the general welfare of its inhabitants, provide basic services to the constituents and enact ordinances which shall ensure the effective and efficient delivery of services;

WHEREAS, the Juvenile Justice and Welfare Council (JJWC) created by virtue of Republic Act 9344 otherwise known as the Juvenile Justice and Welfare Act of 2006 provides Comprehensive National Juvenile Intervention Program Framework to ensure the effective implementation of the Act to serve as guide for LGU's in the preparation of their respective Intervention and Diversion Programs for Children, Children at risk (CAR) and Children in Conflict with the Law (CICL);

WHEREAS, Section 18 of RA 9344 requires Local Government Units to develop a Comprehensive Juvenile Intervention Program covering at least three year period and set aside an amount necessary to implement the said program;

WHEREAS, under the Executive Order No. 33, Series of 2019, Local Council for the Protection of Children (LCPC) was constituted which functions in the formulation of programs that are relevant and responsive to the diverse needs of CAR and CICL population;

WHEREAS, the Comprehensive Local Juvenile Intervention program 2018-2019 is an essential guidebook that contains specific strategies, targets and timetables on the Implementation of the Juvenile Intervention and diversion programs of the Municipality of Lingayen;

WHEREAS, programs stipulated in the Comprehensive Local Juvenile Intervention Program 2018-2019 are found to be sound and feasible by the Sangguniang Bayan of Lingayen;

WHEREFORE, on motion of SBM Ramon Anselmo M. Cuaresma duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:
