RESOLUTION AUTHORIZING HON. LEOPOLDO N. BATAOIL, MUNICIPAL MAYOR OF LINGAYEN, TO PICK OUT ONE SINGLE INTERNET SERVICE PROVIDER (ISP) FOR THE ENTIRE MUNICIPAL HALL BUILDING, THIS MUNICIPALITY.

WHEREAS, internet usage is already an integral part of human living;

WHEREAS, it is a powerful tool in communication, information, technology, education, and government services which is widely used by people in all walks of life particularly students, professionals and government workers;

WHEREAS, government offices use them in searching information, data gathering, sending out and receiving electronic mails, and contacting peoples and organizations;

WHEREAS, at present, different internet service providers are servicing the different offices of the LGU which is proving to be more expensive on the part of the municipal government;

WHEREAS, to minimize the LGU's expense on internet connection, it is best to have one single internet service provider which has the capability to service all offices with reliable and speedy internet connectivity;

WHEREAS, in so doing, the Local Government Unit will have 1 central connection that could service all the offices, and employees can enjoy fast internet and unlimited access to enhance their work productivity;

WHEREAS, with only 1 service provider, troubleshooting/repair and enhancements could be easily undertaken by the preferred internet service provider thus saving time efforts and resources for the municipality;

WHEREFORE, on motion of SBM John Silvester A. Tapia duly seconded by all, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Leopoldo N. Bataoil, Municipal Mayor of Lingayen, to pick out one single Internet Service Provider (ISP) for the entire municipal hall building, this municipality.


