RESOLUTION NO. 70, S-2019

A RESOLUTION REQUESTING HON. FRANCIS 'KIKO' PANGILINAN, SENATOR OF THE REPUBLIC OF THE PHILIPPINES FOR TEN MILLION (Php10M) PESOS FUNDING FOR THE CONCRETING OF ROAD WITH DRAINAGE SYSTEM AT TORRES BUGALLON STREET, BARACA/HEROES STREET, BURGOS STREET AND JACOBA STREET, ALL SITUATED IN BRGY. POBLACION, THIS MUNICIPALITY.

WHEREAS, Brgy. Poblacion is the central business district of the town and the most populated barangay of the municipality;

WHEREAS, due to high volume of vehicles traversing the town's busy major thoroughfares, traffic is oftentimes rerouted to side streets to shorten travel time;

WHEREAS, as a result, these side streets bear the brunt of the high volume of vehicles which led to their deterioration;

WHEREAS, the sad state of the streets are aggravated by flooding which greatly affects the commuters and motorists alike, and leaves a bad impression to the visitors and tourists of the town;

WHEREAS, it is the desire of the municipal government to rehabilitate these roads and to provide drainage systems to ease the suffering of those affected; help facilitate smooth traffic, and ensure the over-all beautification and improvements of roads in downtown Lingayen;

WHEREAS, the current budget allocation of the municipality cannot sustain all its projects and is relying on the benevolence of kind public officials like the good Senator Francis "Kiko" Pangilinan to assist in it's programs;

WHEREFORE, on motion of SBM John Silvester A. Tapia duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Hon. Francis "Kiko" Pangilinan, Senator of the Republic of the Philippines for Ten Million (Php 10M) Pesos funding for the concreting of road with drainage system at Torres Bugallon Street, Baraca/Heroes Street, Burgos Street and Jacoba Street, all situated in Brgy. Poblacion, this municipality.

RESOLVED FURTHER, that a copy of this resolution be furnished the Hon. Senator Francis "Kiko" Pangilinan, House of Senate, Metro Manila for his appropriate action.
