This has reference to Sangguniang Bayan **Resolution No. 79, S-2019** of the Sangguniang Bayan of **Lingayen, Pangasinan**, entitled: "A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) FOR CY 2019 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN", which you have requested our office for technical study and recommendation.

Based on the preliminary review conducted by this office, hereunder are our findings:

1. **Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991.** The Local Development Council of Lingayen, Pangasinan had identified items in their Supplemental Investment Program. This was endorsed to the Sangguniang Bayan for approval on September 26, 2019 thru MDC Resolution No. 01, Series of 2019 and was favorably acted upon by the Sangguniang Bayan on October 14, 2019 thru SB Resolution No. 79, Series of 2019.
2. The Supplemental Investment Program of the municipality covers fund augmentation for the Personal Services, and Maintenance and Other Operating Expenses and Capital Outlay of various municipal government offices and implementation of disaster risk reduction projects of the municipality.
3. The proposed Supplemental Investment Program has an investment requirement of P32,319,461.04. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 1 CY 2019 which was passed and approved by their Sangguniang Bayan on October 14, 2019 thru Appropriation Ordinance No. 1, series of 2019.

In view of the above findings, Resolution No. 79, S-2019 of Lingayen, Pangasinan, may be **considered favorably** by the Provincial Board.
