RESOLUTION NO. 91, S-2019

ADOPTING REPUBLIC ACT NO. 11148, OTHERWISE KNOWN AS THE "KALUSUGAN AT NUTRISYON NG MAG-NANAY ACT". THIS MUNICIPALITY.

WHEREAS, pursuant to Article II, Section 15 of the 1987 Constitution, the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the State shall adhere and guarantee the right to adequate food, care and nutrition to pregnant and lactating mothers including adolescent girls, women and reproductive age and especially children from zero (0) to two (2) years old;

WHEREAS, it is also the purpose of the state to eliminate hunger and reduce all forms of malnutrition;

WHEREAS, Republic Act No. 11148, An Act Scaling Up the National and Local Health and Nutrition Programs through a Strengthened Integrated Strategy for Maternal, Neonatal, Child Health and Nutrition in the First One Thousand (1,000) Days of Life, Appropriating Funds therefor and for other purposes, shall form as an integral part of this resolution;
