AUTHORIZING HONORABLE MAYOR LEOPOLDO N. BATAOIL, REPRESENTING THE MUNICIPALITY OF LINGAYEN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE LANDBANK OF THE PHILIPPINES (LBP) FOR THE ELECTRONIC SALARY LOAN (ESL).

WHEREAS, the LandBank of the Philippines, a government financial institution created and existing under and by virtue of the provision of Republic Act No. 3844, as amended, with principal office at LandBank Plaza 1598 M.A. del Pilar cor Dr. J. Quintos Street, Malate, Manila, represented by its President and Chief Executive Officer, CECILIA C. BORROMEO through her duly authorized representative, KATHLEEN D. FERNANDEZ hereinafter referred to as "LANDBANK";

WHEREAS, the Local Government Unit of Lingayen, a local government unit created and existing under and by virtue of Philippine laws with principal office address at Poblacion, Lingayen, Pangasinan, represented herein by its Municipal Mayor, HON.
