RESOLUTION NO. 97, S-2019

DECLARING APPROPRIATION ORDINANCE NO. 1, S-2019 OF THE SANGGUNIANG BARANGAY OF POBLACION, LINGAYEN, PANGASINAN OPERATIVE.

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Lingayen, Pangasinan as a legislative body is empowered to review ordinances authorizing annual or supplemental appropriations of barangays in the manner prescribed by law;

WHEREAS, the Sangguniang Barangay of Poblacion, Lingayen, Pangasinan submitted its Supplemental Budget No. 1, CY-2019, which was approved on August 5, 2019 through Appropriation Ordinance No. 1, S-2019;

WHEREAS, the Committee on Appropriation & Finance of the Sangguniang Bayan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, conducted preliminary review and study on said budget and hereby recommends to declare it OPERATIVE effective as of the date fixed in the Appropriation Ordinance subject however to the following condition, observation and recommendation:

1. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 or the Government Procurement Reform Act.

WHEREAS, the Sangguniang Bayan after final evaluation, finds the same in order;

WHEREFORE, on motion of SB Member Jay Mark Kevin D. Crisostomo, duly seconded by SB Members Mac Dexter G. Malicdem and John Silvester A. Tapia, it was:


