RESOLUTION NO. 017, S-2022

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL TO EXECUTE AND SIGN THE MEMORANDUM OF AGREEMENT RELATIVE TO THE PROPOSED PROJECT ENTITLED, "PHILSYS BIRTH REGISTRATION ASSISTANCE PROJECT FOR THE MUNICIPALITY OF LINGAYEN" BETWEEN THE MUNICIPAL GOVERNMENT AND PHILIPPINE STATISTICS AUTHORITY (PSA).

WHEREAS, the Office of the Mayor forwarded to the Sangguniang Bayan a copy of the draft MOA between the PSA, represented by Atty. Sheila O. De Guzman, Regional Director, PSA RSSO1, and the Municipal Government regarding the implementation of the said program, and requested the Council for a resolution authorizing the Mayor to enter and sign into a MOA;

WHEREAS, the proposed project aims to increase civil registration in marginalized communities, particularly those belonging to the Indigenous Peoples (IP), Muslim Filipinos, and the poorest of the poor;

WHEREAS, the target of the program is to provide the disadvantaged sector their own PhilID under the Philippine Identification System Act (Republic Act No. 11055) where the birth certificate is a basic requirement;

WHEREAS, the Local Government Unit of Lingayen have manifested its cooperation by allowing the conduct of Mobile Registration in the Municipality of Lingayen to provide services to its constituents;

WHEREAS, Section 444 (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Municipal Mayor upon authorization by the Sangguniang Bayan shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, as per review by the Municipal Legal Officer, the provisions, stipulations, terms and conditions of the said MOA are found to be proper and not contrary to law;

WHEREFORE, on motion of SBM John Marc M. Lopez, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor, Honorable Leopoldo N. Bataoil to execute and sign the Memorandum of Agreement relative to the Proposed Project, entitled, "PhilSys Birth Registration Assistance Project for the Municipality of Lingayen" between the Municipal Government and Philippine Statistics Authority (PSA).

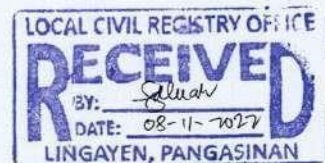
