**RESOLUTION NO. 024, S-2022**

**REQUESTING HONORABLE MAYOR LEOPOLDO N. BATAOIL TO REVERT THE FINANCIAL ASSISTANCE FOR SENIOR CITIZEN PRESIDENTS AS STATED IN RESOLUTION NO. 229, S-2020, BACK TO ITS ORIGINAL PURPOSE AS TRAVELLING ALLOWANCE BUDGET OF ALL CHAPTER PRESIDENTS OF THE SENIOR CITIZENS ASSOCIATION OF LINGAYEN.**

WHEREAS, in recognition of the rights of senior citizens to take their proper place in society, the Municipal Government of Lingayen has allocated a monthly travelling allowance for Senior Citizen Presidents in the amount of One Thousand Pesos (₱1,000.00) to cover their travel expense as they go about performing their functions as leaders of their sector;

WHEREAS, during the community quarantine which has started on March of 2020, senior citizens are not allowed to go out due to their vulnerability to the Corona Virus Disease (COVID-19), thus hindering them from converging and attending meetings and other social obligations;

WHEREAS, having been deprived of their social and economic activities, the earmarked amount for travelling expense has been unused for some time wherefore the same was converted into financial assistance utilized in providing economic relief to defray expenses for food, medicines and other essential supplies for senior citizens during the pandemic; such is a manifestation of this LGU's care and support to the senior citizens of Lingayen who were feeling lonely, depressed and isolated because of the quarantine life;

WHEREAS, with the new normal and lifting of quarantine per Inter Agency task Force on COVID-19, senior citizen presidents are back to their feet once again; all-set to perform their official functions as representatives of their respective barangays;

WHEREAS, said allocation is needed to be reverted to its original purpose as travelling allowance budget to help compensate their expenses as their barangay's representative to fully satisfy their duties and responsibilities as president of their corresponding chapters;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by all members present, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Honorable Mayor Leopoldo N. Bataoil to revert the financial assistance for senior citizen presidents as stated in Resolution No. 229, S-2020, back to its original purpose as travelling allowance budget of all chapter presidents of the Senior Citizens Association of Lingayen.

RESOLVED FURTHER, that copies of this resolution be furnished to the Municipal Mayor, the Municipal Budget Officer, Municipal Accountant, Municipal Treasurer, and the Federation President of Senior Citizens of Lingayen for their information and guidance.
