RESOLUTION NO. 570, S-2022

REQUESTING DIWA PARTYLIST TO ALLOCATE FOUR (4) PIECES TWO-WAY RADIO COMMUNICATION EQUIPMENT FOR EVERY BARANGAY OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, the Municipality of Lingayen is the capital town of the Province of Pangasinan consisting of Thirty-Two (32) barangays with a population of 107,728 people based on the 2020 census results;

WHEREAS, Lingayen is a fast-developing municipality in the North in terms of economic and tourism growth;

WHEREAS, as a consequence of the economic transformation of Lingayen, the population has increased and there is now a bigger demand for better and faster public service from the local government;

WHEREAS, communication plays an important role in the delivery of basic services to the people especially in times of calamities and emergencies where time is of the essence;

WHEREAS, one such equipment badly needed in these operations is the two-way radio which sends and receives audio and data through radio waves;

WHEREAS, said equipment will enhance the communication capabilities of the Barangay Officials and Barangay Peacekeepers through the fast transmission of messages and information and situation updates for the maintenance of peace and order in the barangays;

WHEREAS, the Municipal Government is not capable of providing the needed number of two-way radios for all the barangays and has to source out from well-meaning persons, entities and organizations for its provision;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request DIWA Partylist to allocate four (4) pieces two-way radio communication equipment for every barangay of the Municipality of Lingayen, Pangasinan.

RESOLVED FURTHER, that a copy of this resolution be furnished to Hon. Michael Edgar Y. Aglipay, Representative, DIWA Partylist, for his information and favorable action.


