REQUESTING DIWA PARTYLIST TO DONATE TRANSPORTATION VEHICLES TO THE THIRTY-TWO (32) BARANGAYS OF LINGAYEN FOR USE OF CVOS AND BARANGAY TANODS.

WHEREAS, Civilian Volunteers Organization (CVOs) and Barangay Tanods are force multipliers that assists the government and Philippine National Police in the maintenance of peace and order in the community and in suppressing crimes;

WHEREAS, pursuant to their duties and functions, they conduct nightly patrols by foot, necessarily exposing their lives and limbs in the hands of criminal elements and other obstinate members of society;

WHEREAS, they also serve as first responders during fights, melees, commotions, accidents, thefts and crimes happening in their respective barangays;

WHEREAS, considering the rise in theft and other criminal activities due to the prevailing pandemic, Barangay Tanods and CVOs are having a hard time going after criminal elements without the needed transportation support service;
